CompanAIn, Inc. is collecting your personal information and sensitive personal information to provide and operate the CompanAIn app, including for account creation and management, customer support, security, fraud prevention, payment processing, and to improve our services. If you choose to upload information about your pets (such as veterinary records, lab results, notes, and other health-related information), we use it to provide app features (e.g., timeline, insights, reminders, and recommendations).
